- Duly Accomplished Verified Petition (R.A. 9225 Form No. 1)
- Notarized Oath of Allegiance
- Two (2) pieces – 2 x 2 colored pictures over white background
- Proof of Payment of application fee – **Original Receipt/s** (Php2,500.00)
- Proof as natural-born Philippine Citizen – the original and a copy of at least one (1) of the following must be submitted:
  - Philippine Birth Certificate;
  - Old Philippine Passport;
  - Voter's Affidavit or voter's identification card;
  - Marriage Contract; and/or
  - Other document/s that would indicate that the applicant is a former natural born Philippine citizen
- Photocopy of foreign passport
- Photocopy of Certificate of Naturalization or an original affidavit stating how foreign citizenship was acquired
- Additional Requirements for BI-registered applicants:
  - Original Alien Certificate of Registration (ACR)
  - Original Immigrant Certificate of Residence (ICR) or Certificate of Residence for Temporary Visitor (CRTV)
- Two (2) pieces of self-addressed stamped envelope (legal size)
- If with Dependent/s, the following additional documents are acquired for EACH dependent:
  - Two (2) pieces – 2 x 2 colored pictures over white background;
  - Photocopy of Birth Certificate;
  - Photocopy of foreign passport; and
  - Proof of Payment of application fee – **Original Receipt/s** (Php1,250.00)

Note: All applications must be properly fastened in a legal size folder.
